Specific part

1 Technical description of the product

This European Technical Assessment applies to the factory-made thermal insulation boards made of microporous, water-repellent silica, binding fibers and opacifier with the designations "Kingspan AlphaCore", "Kingspan AlphaCore Pure" and "Kingspan AlphaCore Pure A1", hereafter referred to as thermal insulation boards.

The thermal insulation boards are mechanically compressed and can have a water-repellent treatment. The thermal insulation boards are not coated or laminated and are made with the following dimensions:

Nominal thicknesses: 20 mm to 100 mm ("Kingspan AlphaCore", "Kingspan AlphaCore Pure") 10 mm to 30 mm ("Kingspan AlphaCore Pure A1")

Nominal length: \leq 1200 mmNominal widths: \leq 1200 mm

Special dimensions deviating from the above nominal length and nominal widths are possible.

The European Technical Assessment has been issued for the product on the basis of agreed data/ information, deposited with Deutsches Institut für Bautechnik, which identifies the product that has been assessed. The European Technical Assessment applies only to products corresponding to this agreed data/information.

2 Specification of the intended use in accordance with the applicable European Assessment Document (EAD)

The thermal insulation boards can be used for the following intended uses:

- External insulation of roofs or floors protected from precipitation, wetting or weathering, below coverings or waterproofing
- Internal insulation of ceilings (underside) or roofs and insulation below the rafters/supporting structure, suspended ceilings
- Internal insulation of floors or bedplates (on the top) below floor screed without requirements regarding protection against noise
- External insulation of walls behind cladding
- External insulation of walls under plaster
- Internal insulation of walls
- Insulation (core insulation) of double wall masonry (up to total layer thickness of 150 mm)
- Insulation of walls with timber frame construction and closed panel timber frame construction or comparable partitions

The performance according to section 3 only applies if the thermal insulation boards are installed according to the manufacturer's installation instructions and if they are protected from precipitation, wetting or weathering in built-in state and during transport, storage and installation. When calculating the thermal resistance, the nominal thickness of the insulation materials shall be applied.

Where the thermal insulation boards are installed in two layers up to a maximum thickness of 100 mm or in three layers up to a maximum thickness of 150 mm, the thermal insulation boards are either laid in place loosely or fixed with non-combustible mechanical means of fixing.

Where the thermal insulation boards are fixed by using mechanical means of fixing, only such mechanical means of fixing shall be used, which are suitable for this purpose. The assessment of these fixings is not subject of this European Technical Assessment.
